



PLAYER'S CONTRACT

I agree to the following guidelines:

1. I will respect the game of baseball, and understand that it is a privilege, which can be lost.
2. I will be on time.
3. I will always give 100% on the bench, in the game, or in practice.
4. I will always encourage my teammates even if I am not playing.
5. I understand that it takes nine players to play a game and I will play any position that the coach wants me to with the best of my ability.
6. My uniform will be worn properly at all times (shirt tucked in, hat straight). If I do not wear my correct uniform at practices and games I understand that there will be consequences (equipment pick up after practice, field maintenance after practice, dugout and field clean up after practice, etc.).
7. I will address all staff members with, "Coach", "Sir", or "Mr."
8. I will always be prepared by bringing all of my equipment to every practice/game. If I am a catcher I will always have my gear ready.
9. I understand it is not my parent's responsibility to bring my equipment and uniforms to games/practices.
10. I will respect teammates, equipment, facilities, and umpires at all times (Umpires will be dealt with by **TWI** staff.)
11. I will not talk to anyone other than my coaches and teammates once practices and games start.
12. I WILL ALWAYS BE POSITIVE and have FUN.

1. I will trust that **TWI** is doing the right thing for my child, which includes: Playing Time/Defensive Position/Batting Order Position.

4. I will stay 30 feet away from the dugout during practices/games. The 30-foot rule is in place to protect the young athlete. I understand that my child will have success as well as failures, and that they need space to grow. I am trusting that the **TWI** coaches will handle my child's instructions. I will let the **TWI** staff do their job for the allotted time. If I have any issues, I will wait until an appropriate time following a game or practice to address the staff.
5. I will feed and hydrate my child prior to the practices or games.
6. Punctuality is an important part of life. If my child is late, **TWI** will discipline my child in a fair manner to show favor to those which were on time.
